**20/118: Present:** Cllr E Sturgess (Chair), Cllr A Hardy, Cllr P Tomiak-Baquero, Stroud District Councillor J Dewey, Cllr G Warden, Susan Black, clerk.

**20/119: Apologies:** Cllr S Cowle (vice Chair), GCC Cllr Lorraine Patrick.

**20/120: Minutes:** The Minutes of the meeting held on 14<sup>th</sup> September 2020 were unanimously agreed remotely and will be signed when the lockdown process allows.

20/121: Public questions/participation: None.

**20/122: Welcome & Introduction New Councillor:** The Chair, on behalf of the Parish Council, welcomed Gemma Warden as its new councillor.

# 20/124: SDC planning matters:

## a) Decision:

S.18/0815/OUT (resubmission) demolition of The New Lawn Football Stadium (Forest Green Rovers FC) and re-development to provide the erection of up to 95 dwellings. **Awaiting decision** 

- **20/125: Glebe Land Update:** The Chair reported she still awaits hearing from Bruton Knowles, the agents for the Diocese regarding the management of the land.
- **20/126: Glebe Land (Kissing Gate) Update:** The Chair to contact the contractors who installed the gate to arrange a site meeting. Clerk to circulate photos of site.
- **20/127:** Location of Ancient Stiles: Cllr Hardy advised that a register of every site identified needs to be recorded. The Chair will action this when time permits.
- 20/128: Playing Fields Committee: Cllr Cowle to update at next meeting.
- **20/129: Cockadilly Gateway Scheme Update:** Cllr Tomiak-Baquero advised that the work is hoped to go ahead before winter alongside two other gateway schemes which are being conducted as part of the same "job". It was acknowledged and appreciated that Cllr L Patrick has set aside funding of £5,000 for all three schemes which it is hoped will cover all the costs.

**20/130:** Acquisition of Defribillator: Cllr Tomiak-Baquero provided a summary of the varieties of defribillator available plus costs. He will do further research on which is the best

one to use and will update at next meeting. Options for location of the defribillator was discussed, with sites outside St Jude's Care Home or the Club being considered.

**20/131: Tinkley Lane Passing Places:** Following Cllr L Patrick's email suggestion of a collaborative approach to the pot hole issues in Tinkley Lane, the clerk was requested to contact Cllr L Patrick again to request a meeting on the subject. The Council reiterated their need to be involved in the process of the resolution of this issue.

**20/132: Financial Matters:** Payments of the Council for October 2020: These were approved and will be signed by Cllr Cowle as internal auditor after lockdown ends.
