22/027: Present:

22/029: Minutes and Declarations:

The revised Minutes of the meeting held on 14th February were approved. No declarations of personal interest were received.

22/030: District and County councillors' reports:

County Councillor Thomas via email.

- Highways

Frocester Hill Junction with B4066: Phone call with the local Highways Manager at the end of February to find out what the timetable for designing an improved junction will be. Despite pressing for some indication of dates, he could not give me any specific timeframe for this. I would suggest the PC also ask this question directly, to keep the pressure on.

- Stagecoach West bus service

The strike action has been cancelled as the drivers were able to reach a satisfactory pay deal with Stagecoach.

- Funds have been made available to increase tourism in the Stroud area including appointing a tourism officer.
- Retrofitting of council houses, enabling them to be more energy efficient, has been agreed by SDC
