MINUTES of the meeting of Nympsfield Parish Council (NPC) held at Nympsfield Village Hall on Monday, 13th February 2023

23/016: Present:

Cllr S Price (Chair), Cllr P Tomiak-Baquero, Cllr T Gaunt, Cllr R Clements, Cllr A Robertson, GCC Cllr W Thomas, SDC Cllr M Pearcy, C Fairbrother (Clerk).

23/017: Minutes and Declarations:

The Draft Minutes of the 9th January meeting were unanimously approved. No declarations of personal interest were received.

23/018: Public Participation: None this month.

23/019: District and County Councillors' reports:

Both reports received with thanks. Cllr Thomas gave a summary of her latest correspondence with Gloucester Highways re Frocester Hill junction. Correspondence was also reported with Andy Birchley of Gloucester CC regarding Smith's earthworks etc on David's Lane. Sophie Holley of Stroud DC planning enforcement will investigate and report, however Smiths do have a licence to bring a limited amount of materials on site. The bunds along David's Lane and elsewhere were seen as boundary construction and therefore would be permitted agricultural development. Julian Thomas was named by SDC Cllr Pearcy as a new interim planning enforcement officer. Cllr Pearcy also mentioned the Stroud Town and Parish Charter, parish councils are encouraged to sign up.

23/020: Planning matters:

23/021: Grant Applications:

Cllr Tomiak-Baquero noted that Stroud News have published his submission about the dangers of Frocester Hill junction. A further recent incident involving a lorry was noted. He also noted that Gloucester Highways' department have failed to acknowledge or respond to his comprehensive report on the incidents which took place over the Christmas period.

23/026: Glebe:

Nothing heard this month.

23/027: Bus Shelter:



Rob Gazzard to fill cracks when the weather warms sufficiently for the mortar to set.

23/028: Warm Hub:

Nothing new to report.

23/029: Coronation:

The Village Hall committee have agreed to support a street party.

23/030: Adoption of Town and Parish Charter:

It was noted that the email format required would not allow councillors to sign in. Clerk noted that the NPC email address format would not comply either.

23/031: Bins:

The Playing Field Committee is investigating the possibility of another or a larger waste bin. Stroud DC are considering if they can service it. Chair to follow up with Stroud.
